TRIALS: Trials will be electronically timed elimination trials. The 10 fastest times will be placed in the futurity and the next 10 fastest times will be placed in the consolation. If the electrical timer fails in any trial, the stewards may determine the finalists for the futurity and the consolation by hand timing or order of finish in the trials. Times will be taken at 1/1000th of a second. If a tie should occur any decisions shall be determined by lot. Should a horse be disqualified it shall be given the time of the horse it is placed behind plus 1/1000th of a second. If the gate fails to open in the trials, the horse shall be declared a non-starter and all nominating and entry fees, less administrative and promotional monies, will be refunded. If the gate fails to open during the futurity or consolation the horse shall be declared a non-starter and placed last in the respective race. Each trial shall consist of not more than 10 horses. In the event 10 or fewer horses enter the trials the OQHRA reserves the right to conduct the futurity without trials including all horses entered. Any situation or incident not covered in these conditions/terms shall be governed by the AQHA time trial procedures.

Horses who enter the trials will be eligible to enter the consolation with fastest times given preference. Any situation or incident not covered in these conditions/terms, shall be governed by the AQHA time trials procedures.

The Association reserves the right to change the dates of the trials or finals or consolation and to establish trial race purses at its discretion.

The purse of the futurity shall consist of the nomination, sustaining and trial entry fees plus added money, less up to 15% for advertising and promotion.
